**REVISIONS TO THE DOCUMENTS**

1. All references in Addendum No. 4 to submission deadlines of January 15 or January 18, 2021 are hereby deleted. The City of Chicago "COC" is updating the Request for Proposal Revisions submission deadline to January 19<sup>th</sup>, 2021 at 12pm CST. This submission deadline encompasses all aspects of the Request for Proposal Revisions and Addendum No. 4, including the Price Refresh, any updated submission related to Form 5 and any updated submission related to Form 6.

**QUESTIONS/ANSWERS**

1. For questions regarding the COC's requirement of firm prices submitted in response to the Request for Proposal Revisions due January 19, 2021, refer to the COC's Answer to Question 34(i) in Addendum No. 3. The COC will treat prices submitted on January 19 as firm until contract execution with the Selected Respondent. The COC cannot advise Respondents regarding their own internal approvals necessary to submit Proposals to the COC and to execute a contract with the COC if selected. Please also refer to the RFP, Exhibit D, Section 4.6 – Exceptions to RFP.
2. For questions regarding the COC's Procurement Timeline in Addendum No. 4 and its impact on a Contract Award date of February 12, please refer to the asterisk in the Timeline noting that all dates "are tentative and subject to change." The COC's goal is to execute a contract with the Selected Respondent as expeditiously as possible but will adjust its timeline as needed to successfully achieve the objectives of the RFP and award a Contract.
3. For questions regarding exceptions taken to the RFP pursuant to Exhibit D, Section 4.6 – Exceptions to RFP, please refer to that Section. Exceptions will be considered in evaluation of Proposals. The COC desires to meet mutually agreeable terms through negotiation but selection of a Proposal does not represent automatic agreement regarding any stated exceptions. Negotiation and discussion regarding any stated exceptions by the Selected Respondent will occur after the Selection of a Selected Respondent.

Any and all Addendums or Clarifications must be acknowledged by the vendor in their Cover Letter. Failure on behalf of the vendor may be cause for rejection of submittal.
