1. Please describe the major features of this project.

Contractor is to pump low voltage manhole and generically survey/investigate to identify two (2) empty conduits between manholes. Contractor is then to mandrell to verify empty non-collapsed connecting conduits within ductbank, install pull cord in two (2) empty conduits. Contractor is to work only in low voltage manholes and ductbank system. Contractor to supply a generic butterfly sketch showing ductbank locations where the pull cords were installed. Contractor shall supply pictures of each face of manhole present (north, south, east & west); make note of number of manholes present at each location. Contractor to work simultaneously with FAA personnel in investigating conduit paths previously found by the Contractor to be impassible along the east and west side of the parking garage.

2. Please explain why this project could not be bid using the city's traditional bid process and the need to use JOC Procurement system.

This is a modification to the base project OH-6126-1-002.A

3. If the project is a one trade project, please provide additional explanation of why it would be in the city's best interest to do the project under JOC:

The Scope of Work will be in accordance with the detailed specifications of the JOC Contract Documents.
