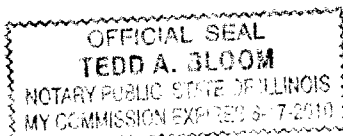

1. Please describe the major features of this project.

Purchase and install four (4) 360 degree Two Mile Aviation Marking Lights, Red Lens, red LED'S for the TW ZJ Blast Deflector Fence. Purchase six (6) 360 degree Two Mile Aviation Marking Lights, Red Lens, red LED'S for the Oil Water Separator.

2. Please explain why this project could not be bid using the city's traditional bid process and the need to use JOC Procurement system.

These obstruction lights are a Department of Aviation and FAA requirement for the commissioning of TW ZJ to be opened April 1, 2007. The TW ZJ Blast Defelctor Fence JOC OH-6310-1-001.A and the Oil Water Separator No. 1 are supporting projectects for the base project South Basin Site Preparation (OMP WBS OH6130.220.50.215). In order to meet the Contractual Completion Date on this base project we have identified JOC as the most practical means for the purchase these obstruction lights.

3. If the project is a one trade project, please provide additional explanation of why it would be in the city's best interest to do the project under JOC:

The base project is multi-trade for concrete, excavation, and electrical.

4. If it is anticipated that over 25% of the project will consist of Non-prepriced items, please provide an explanation on why JOC should be used.

These specific obstruction lights are required and approved by the DOA and FAA for lighting on the airfield and meet the green initiative.

5. If some elements of the proposed JOC project scope of work are covered by city term agreements, explain why they are included in this JOC project instead of being procured through the term agreements.

Term agreements do not currently cover these lights.
