



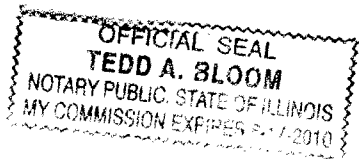

1. Please describe the major features of this project.

The facade and ballustrade of the northwest stairway of the Michigan Avenue bridge has been stabilized. Under the current schedule, the stairway will be reconstructed in 2009. In the interim we have to provide a safe site for pedestrians at the Wendella tour boat operation. Therefore, a canopy will be erected over the ticket window and doorways. The canopy will remain in place for at least two (2) years until the complete reconstruction of the stairs and plaza will be undertaken. This work can not be performed by City Forces and is not covered by an existing term agreement.

2. Please explain why this project could not be bid using the city's traditional bid process and the need to use JOC Procurement system.

The project entails a relatively small scope of work. It would not be time or cost effective for us to perform the work through The City's traditional bid process.
