1. Please describe the major feature of this project.

This project is installing piggyback acorn light fixtures to the existing poles on 69th St from Ashland to Western, on 71st St. from Loomis to Damen, and on Damen from 68th Pl. to 71st St. This project is part of DCEO grant for the 17th Ward.

2. Please explain why this project could not be bid using the city's traditional process and the need to use the JOC procurement system.

The Bureau of Electricity had planned to do this project with City Forces, but due to our work load, we can't do it in a timely manner.
