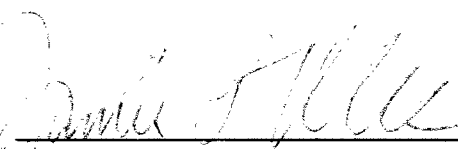

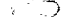

1. Please describe the major feature of this project.

This project is removing 310 watt roadway fixtures, replacing them with 100 watt fixtures and installing a 100 watt acorn piggyback to the existing pole. The project is from Wolcott to Ashland.
